His groundwater cases have run the gamut from chlorinated solvents to MTBE to nitrogen issues. He has also handled a number of toxic tort suits. Ed has also first and second chaired a wide range of cases involving contract disputes and ones with significant actual and punitive damages claims based on business and traditional tort allegations, in addition to a white collar criminal practice.
