### overview

Previously, Kristen served as deputy counsel to the governor of Missouri, where she oversaw legal departments for state agencies, including the Missouri Department of Revenue, and led the governor's judicial selection process. During her tenure, she facilitated the appointment of over 20 judges to St. Louis courts and provided counsel on high-profile legal matters.
